

PHOTOGRAPHY CONTEST REGULATIONS

"Statistics in Photography"

GENERAL PROVISIONS

1. **The organizer of the "Statistics in Photography" Photography Contest** (hereinafter referred to as the "Contest") is Bialystok University of Technology, implemented by the Faculty of Engineering Management, the Scientific Creativity Circle, and the Student Scientific Circle Chess WIZ, all based at Ojca S. Tarasiuka 2 Street, 16-001 Kleosin (hereinafter referred to as the "Organizer").
2. **Contest objectives:**
 - a) Promote the use of statistics in photography
 - b) Foster interest among students in statistics and photographic representation of data
 - c) Develop artistic sensitivity and showcase student creativity in photography
 - d) Explore visual representations of data and their meaning in everyday life
3. **The subject of the Contest** is photographs taken by students that creatively interpret the theme "Statistics in Photography."
4. **The theme of the Contest** is the presentation and promotion of the use of statistics in photography, including data, graphs, statistical analyses integrated with surroundings or everyday life.
5. **Awarded and distinguished works** will be published on the website of the Faculty of Engineering Management of Bialystok University of Technology (<https://wiz.pb.edu.pl/>).
6. **The vernissage and award ceremony** will take place on May 9, 2025, in the hall of the Faculty of Engineering Management (Berlin building), Ojca S. Tarasiuka 2 Street, 16-001 Kleosin.
7. **Participation in the contest is tantamount to acceptance of these regulations.**

SUBMISSION OF WORKS

1. Participation in the contest is free of charge.
2. Each participant may submit a maximum of three photos.
3. The contest is open only to first and second cycle students and doctoral candidates from various universities.
4. Schedule:
 - Submission deadline: April 30, 2025
 - Jury appointment and photo evaluation: May 9, 2025
 - Award ceremony and vernissage: May 9, 2025
5. Photographs must be original and created independently. Joint works (co-authorship) are excluded.
6. Photos must be sent in print format to: Faculty of Engineering Management, Bialystok University of Technology, Ojca S. Tarasiuka 2 Street, room 118 KB, 16-001 Kleosin, labeled "Statistics in Photography Contest" or delivered to the Secretariat of the International Department of Logistics and Service Engineering, room 120 KB, Monday to Friday, 8:00 a.m. – 3:00 p.m.
7. Submissions must include the registration form (Appendix No. 1 to these regulations).
8. Electronic versions of the photos and descriptions must also be sent to: wiz.konferencjaiskn@pb.edu.pl.
9. Photos must be printed in A4 format on photo paper. Only printed versions will be evaluated.
10. Photo montages combining elements from different files are not permitted.

11. The Organizer reserves the right to disqualify works that do not meet the above requirements.
12. If a person appears in a photo, the participant must include a signed statement from that person consenting to the free publication and dissemination of their image.
13. By submitting photos, each participant grants a non-exclusive, royalty-free license to use the photos in the following fields of exploitation: a) fixation and reproduction using any technique, including printing, reprography, magnetic recording, and digital techniques; b) dissemination of the work in ways other than those specified in point a), including public exhibition, display, playback, broadcasting, re-broadcasting, and online sharing. The participant authorizes the Organizer to use the submitted works free of charge by posting them online, in press releases related to the Contest, post-contest exhibitions, posters, and other promotional materials for the Contest and its future editions.

AWARDS

1. Winning photos will be posted on www.wiz.pb.edu.pl, and their authors will receive promotional gifts from Bialystok University of Technology. The photos will also be exhibited in the hall of the Faculty of Engineering Management.
2. Contest prizes are not redeemable for cash.
3. The Organizer reserves the right to publish the names of winners and use this information in promotional materials, press releases, and media including the Internet.

FINAL PROVISIONS

1. The Contest regulations are available at the Organizer's headquarters and online at <https://wiz.pb.edu.pl/>.
2. By completing the registration form, the participant declares that they are the sole author of the submitted photos and hold full copyrights, free from any legal defects or claims from third parties.
3. The participant consents to publication of their photos on the contest website, the WIZ PB social media, and the pages of the Scientific Creativity Circle and Student Scientific Circle Chess WIZ during and after the contest.
4. The participant agrees to the exhibition of their photos in the post-contest exhibition held in the Faculty of Engineering Management (Berlin building) solely for purposes directly related to the Contest.
5. Persons failing to meet any requirements or providing false information will be disqualified.
6. The Organizer is not legally responsible for submitted works and reserves the right to disqualify photos suspected of violating the Regulations.
7. In matters not covered by these Regulations, relevant Polish legal provisions shall apply.
8. The Organizer does not claim ownership of copyright or property rights; submitted works remain the intellectual property of the authors.
9. The Organizer documents the post-contest exhibition for promotional purposes. Selected materials, including participant images, may be posted on the Organizer's website and social media channels. Participation implies consent to the processing of the participant's image for documentation and promotion.
10. By entering the contest, the participant, pursuant to Article 81(1) of the Copyright and Related Rights Act of February 4, 1994 (as amended), consents to the free recording and dissemination of their image on any media by Bialystok University of Technology, Wiejska 45A Street, 15-351 Bialystok, for purposes related to the promotion of the post-contest exhibition and contest winners.
11. The interpretation of these Regulations belongs solely to the Organizer.

INFORMATION FROM THE DATA CONTROLLER IN CONNECTION WITH PERSONAL DATA PROCESSING –
PURSUANT TO ARTICLE 13(1) AND (2) OF THE GENERAL DATA PROTECTION REGULATION (GDPR)

- 3) Your personal data will be processed for the following purposes:
 - a) Registration of Contest participation and its organization
 - b) Announcement of Contest results and publication of winners
 - c) Documentation of the post-contest exhibition through the processing of participants' personal data, including image – based on Article 6(1)(a) and (e) GDPR
- 4) Recipients of your personal data may include IT service providers and other entities legally entitled. For contest winners, personal data (first and last name) may also be made available on the Organizer's website.
- 5) Your personal data will be stored for the time necessary to fulfill the purposes mentioned above and subsequently for a period required by law, particularly in accordance with archiving regulations or until consent is withdrawn.
- 6) You have the right to access your data and, subject to legal provisions, the right to:
 - a) withdraw your consent, with the reservation that the withdrawal does not affect the lawfulness of processing based on consent before its withdrawal,
 - b) rectify your data,
 - c) delete your data,
 - d) restrict data processing,
 - e) object to the processing of personal data.
- 7) You have the right to lodge a complaint with the President of the Personal Data Protection Office if you believe that the processing of your personal data violates applicable legal regulations.
- 8) Providing your personal data is voluntary, but it is a necessary condition for participating in the Contest. Failure to provide personal data will result in the inability to participate in the Contest.
- 9) Your personal data will not be used for automated decision-making or profiling as referred to in Article 22 of the Regulation.
