

## Regulations

### IV International Interdisciplinary Student Scientific Conference

#### "Statistics in Everyday Life"

Kleosin, May 21, 2026

#### 1. General Provisions

- 1.1. The International Interdisciplinary Student Scientific Conference "Statistics in Everyday Life", hereinafter referred to as the Conference, will be held on May 21, 2026, in a hybrid format.
- 1.2. The organizer of the Conference is Bialystok University of Technology - Faculty of Engineering Management of Bialystok University of Technology.
- 1.3. Participants of the event may be first and second cycle students, as well as doctoral school participants.
- 1.4. The Organizer reserves the right to make changes to the program and the Conference Regulations and commits to publishing current information on the website.
- 1.5. These Regulations are binding for all Participants.

#### 2. Terms of Participation and Publication

- 2.1. Participation in the Conference requires registration via the form available on the Conference website by May 3, 2026.
- 2.2. Registration requires providing the Participant's personal data, including name, surname, email address, and other necessary information.
- 2.3. The following types of participation are distinguished:
  - a) Active participant with a presentation/poster and an article for publication
  - b) Active participant with a presentation/poster but without an article for publication
  - c) Passive participant without an article and without a presentation/poster
- 2.4. A Conference Participant interested in publishing an article is obliged to:
  - a) Submit the completed article in electronic form in doc or docx format to the following email address: **wiz.konferencjaiskn@pb.edu.pl** by May 15, 2026. Submitted papers will undergo peer review, and authors will be informed via email about the acceptance of the paper for publication. The Organizers reserve the right to decide on the article's inclusion in a selected issue of the "Academy of Management" journal (20 points as per the Minister of Science's Announcement of January 5, 2024, on the list of scientific journals and reviewed conference materials).
  - b) Student publications in the "Academy of Management" journal are accepted only in co-authorship (under the scientific supervision) of an academic or teaching staff member from the university where at least one of the authors is a student.

- c) Submitted articles must meet the editorial requirements available at: [wiz.pb.edu.pl/akademia-zarzadzania/dla-autorow/formatka-artykułu](http://wiz.pb.edu.pl/akademia-zarzadzania/dla-autorow/formatka-artykułu).

2.5. Participation in the Conference and publication is free of charge.

2.6. Post-conference materials will include a book of abstracts.

2.7. A participant who attends the Conference will receive a certificate of participation.

2.8. A participant may withdraw from the Conference only by sending a notice to the email address: **wiz.konferencjaiskn@pb.edu.pl** by May 18, 2026. Notice of withdrawal is for organizational purposes.

### **3. Consent to Use Image**

3.1. During the Conference, the Organizer may record its course for documentation and promotional purposes.

3.2. Participation in the Conference implies the Participant's consent, free of charge and unlimited in terms of quantity, time, and territory, to the use, processing, reproduction, and multiple distribution of the participant's image recorded in photos and videos taken during the Conference without the need for each time approval, for informational and promotional purposes of the Conference. This consent also means that photos and recordings made during the Conference may be placed on the Internet, in particular on the Conference's website at: <https://wiz.pb.edu.pl/nauka-i-badania/konferencje-i-seminaria/miskn-statystyka/>.

### **4. Personal Data**

4.1. The processing of personal data for the purposes of fulfilling tasks under the Regulations will be carried out in accordance with generally applicable data protection laws, in particular Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 (GDPR) and the Polish Personal Data Protection Act of May 10, 2018.

4.2. The information clause on personal data processing for conference participants is included in the registration form.

4.3. The Organizer takes all appropriate legal and commonly accepted security measures to protect information confidentiality.

### **5. Final Provisions**

5.1. The Organizer reserves the right to use the email address provided during registration to notify Participants about program changes, amendments to the Regulations, and to send invitations to future editions of the Conference.

5.2. The Participant confirms in the registration form that they have read and accept the Regulations.

5.3. The Participant confirms in the registration form that they agree to the free use of their image, voice, and statements recorded during the Conference, as outlined in point 3.2. If the Participant does not consent to the use of their image, they are obliged to notify the Organizer via electronic means no later than one day before the start of the Conference.

5.4. Any disputes arising from participation in the Conference will be resolved by the court with jurisdiction over the Organizer's seat.

5.5. In matters not regulated by these Regulations, the provisions of the Polish Civil Code shall apply.
